The City is requesting sealed bids for **CHAMPIONS HALL RESTROOM REMODEL** for the City of North Lauderdale. Sealed proposals, including one (1) original, three (3) copies, and one (1) single pdf file on a flash drive, addressed to the Purchasing Division of the City of North Lauderdale, Broward County, Florida, and will be accepted by the Office of the City Clerk, 701 SW 71st Avenue, North Lauderdale, Florida 33068 until 10:00 am EST, **Wednesday, March 13, 2019** for:

**SCOPE OF WORK:** The City of North Lauderdale wishes to contract with a licensed and insured Contractor to remodel both the Women's and Men's restrooms at Champions Hall, **6601 Blvd of Champions, North Lauderdale, FL 33068**. The project should be completed within four (4) weeks (Monday, July 1, 2019 to no later than Saturday, July 27, 2019).

The awarded Contractor will be providing all necessary labor and equipment for successful completion of the project. The City will provide all the necessary materials and supplies. The City will provide a construction dumpster for the Contractor's use. The City will have a certified electrician available for electrical work as needed.

- **Remove:** All existing floor tile, partitions/urinal screens, plumbing and lighting fixtures; and all restroom accessories in both restrooms
- **Install:** New floor tile, partitions/urinal screens, plumbing and lighting fixtures; and all restroom accessories in both restrooms. Installation of new concrete board over existing wall tile, new wall tile and paint, where applicable, in both restrooms.
