#### SECTION II – Acknowledgements:

This is to certify that:

1. The alarm system has the capacity to prevent false alarms by the use of a backup power supply.
2. Alarm registration stickers issued by the Police Department are non-assignable and are issued and effective only for the registered alarm system and alarm user.
3. Before placing a system into operation, every alarm user shall prominently post the alarm system's registration number at or near the front entrance of the premises so that it is visible from the outside of the structure.
4. Every alarm user registered under this section shall be required to provide the Community Development and the Police Departments with any changes in the information submitted on the registration application when such changes occur.
5. The applicant further agrees to hold the City harmless and indemnifies the City from any property damage to the registered location that was deemed reasonably necessary by the Police or Fire Department, in order to respond adequately to an alarm.
6. Penalty for false alarms (CH 82-304):  
4 – 5 \$25.00 EA  
6 – 7 \$50.00 EA  
8 or more \$75.00 EA

# Attention Residents



## *Burglar Alarm Registration Notice*

**The City of North Lauderdale has instituted an alarm ordinance Sec. 82-321 that requires ALL RESIDENTS AND/OR BUSINESSES with alarm systems to register with the Community Development Department.**

This law was instituted because of a high number of false alarm calls in North Lauderdale. The initial registration fee is \$25.00. The registration requires a \$10.00 renewal fee with the City each Year if you had four or more false alarms during the year. If the alarm owner has three or less false alarm calls during the year, the annual renewal fee will be waived and automatically renewed. **Effective as of January 8, 2008, the ordinance was amended to include Sec 82-308, which in the event that the City's Public Safety Department responds to an alarm and determines that the alarm is not registered with the City, there will be an additional \$50.00 fine issued immediately and the property owner must also register the alarm with the City**

### THE FOLLOWING PENALTIES WILL BE ASSESSED:

- **4-5 false alarms during the calendar year will result in a \$25 fine each.**
- **6-7 false alarms during the calendar year will result in a \$50 fine each.**
- **8 or more false alarms during the calendar year will result in a \$75 fine each.**
- **20 or more false alarms during the calendar year will result in the alarm registration being revoked and possible removal of the alarm system.**
