



**TEMPORARY PARKING OR STORAGE OF  
OPERABLE UNREGISTERED VEHICLES  
(Section 106-205)**

**Purpose:**

A resident of the City and the owner of an operable vehicle without a current state registration may apply for a temporary permit which will allow storage of said vehicle on private property outside of a garage or other enclosed structure for a period of time of up to one year.

**Required Documentation:**

Notarized affidavit stating that the vehicle will not be driven on public right of way during the permit period

**Additional Requirements:**

- Vehicle for which permit is issued is operable
- No more than one vehicle per household is eligible
- The vehicle for which the permit is issued shall be parked on private property on an approved hard surface, supplementary parking space in compliance with Section 106-222.
- The permitted vehicle shall only be parked at the owner's address as set forth in this application.
- Any un-expired permit shall be returned to the City upon removal of the vehicle from the premises or a copy of a valid State registration for the permitted vehicle must be provided.
