NOTICE:

North Lauderdale’s Community Development Department provides information on Code Enforcement violations, permits and code enforcement liens assessed by the City. Results provided are based on information available at the time a search is completed and signed by the Community Development Department Administrative Clerk.

To request a lien search, there is a **\$45** charge per search. Searches take approximately 10-15 business days to complete depending upon the volume. Currently, we are experiencing a large volume of lien search requests. Therefore, it is advised that you make your request within a reasonable time in anticipation of the property closing.

Once a lien search is completed a request for lien settlement must be submitted. There is a **\$55** fee for Lien Settlement Requests and the form can be downloaded from our website at www.nlauderdale.org/documentcenter/formsandapplications/index.php#. A property must be in compliance before payoff calculations will be completed.
